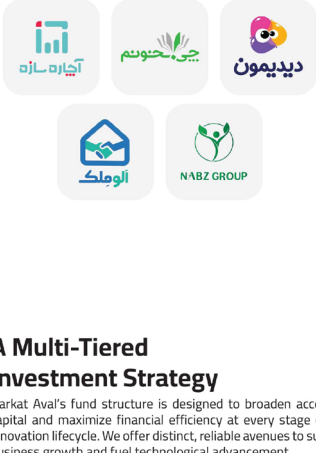

Hamrah Fund: Strategic Venture Capital

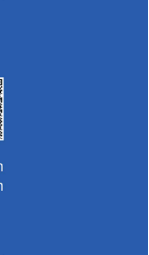
